**APPROVAL U/S. 80G(5)(vi) OF THE Income-tax ACT, 1961 :**

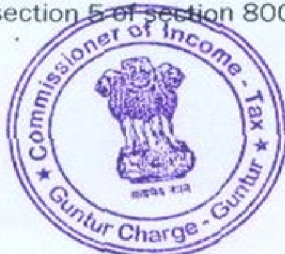
The application filed in Form No.10G seeking exemption u/s 80G in the above case, on 27-07-2011 has been examined and found eligible that-

- i) This is a fund/trust as mentioned in clause (iv) of sub section 2 of Sec.80G of the Income-tax Act 1961;
- ii) The donation made to the said trust/fund/society do qualify for deduction in computing the income of a person who makes the donation i.e., in the hands of the donor.

Accordingly the approval sought for is hereby accorded u/s.80G(5) of the Income-tax Act, subject to the following.

The approval shall have effect from 01-04-2012 onwards for a period of two years subject to all other provisions of Income-tax Act, 1961, as applicable.


- i) The receipts issued to the donors should bear the number and the date of this order and the period of validity.
- ii) The Trust/Society shall submit the statement of income and expenditure for the year ended on 31-03-2013 and subsequent year(s) within the prescribed time before the prescribed authority.
- iii) The Trust/Society seeking exemption shall fulfill the conditions mentioned in sub-section 5 of section 80G of Income-tax Act 1961.
